Even to the Death, Fight for Truth (Sir 4:28)

Arizona SB 1457

Below are the major elements of a new state law signed by Governor Doug Ducey.

Abortionist must inform the woman it is unlawful “to perform an abortion due to the child’s race, sex, or genetic abnormality.”

Makes it a felony for a doctor to perform an abortion if the sole reason the woman seeks it is that the fetus has a genetic abnormality,

Clarifies the definition of genetic abnormality,

Forbids the mailing or delivery of abortion-inducing drugs,

Requires fetal remains to be buried or cremated,

Imposes new reporting requirements on medical facilities,

Prohibits public educational institutions from performing abortions unless the mother’s life is in jeopardy.

Prevents public money from supporting research involving abortions or embryo transfers,

Recognize that an unborn child has “all rights, privileges and immunities available to other persons, citizens and residents of this state”.

Thank you legislators and Gov Ducey.

Fetal Pain

Below is an abstract from the ACPeds paper on fetal pain asserting pain may be felt as early as 12 weeks (LMP) and possibly earlier.

“The American College of Pediatricians ([ACPeds](#)) maintains that it is unethical to intentionally harm an innocent human being even in the absence of the individual’s ability to perceive pain. However, in this paper, ACPeds reviews the laboratory and clinical evidence which indicates that as early as 12 weeks gestation (and possibly earlier) exposure to noxious stimuli negatively affects immature human beings. Because of the resulting acute stress responses and subsequent potential long-term negative effects, the ACPeds holds that avoiding, mitigating, and directly treating fetal, neonatal, and pediatric pain is a medical and ethical obligation.”
