Hyde Amendment

It is no small issue that President Biden's recent budget proposal excludes the Hyde amendment after 40 years of being included.

The Hyde Amendment, an annual amendment to appropriations bills prohibiting the use of federal funding to pay for abortion, was first enacted in 1976. This amendment has saved millions of unborn lives.

It is up to each of us to do our parts to ensure this amendment is reinstated by contacting our congressional representatives.

Weldon Amendment

Also missing from the appropriations bills is Weldon Amendment language which protects the conscience rights of medical providers and prevents them from being forced to participate in an abortion.
